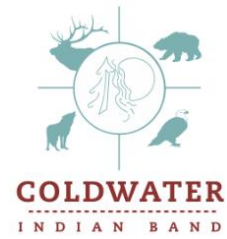


Coldwater Indian Band Community Involvement Bursary 2021 Application



Purpose:

The Coldwater Indian Band is a member of the Nlaka'pamux Nation and is part of NVIT's reason for being. Coldwater Indian Band's mission statement is to "enhance and sustain our quality of life through wellness and culture, and to utilize and preserve all our resources for now and future generations" and thus is committed to providing equal education opportunities for Band members.

Eligibility:

Awarded to four (4) full-time Indigenous students from the Merritt campus who are members of the Coldwater Indian Band. Students must be enrolled in at least 60% course loads in any field of study (Developmental Education, Employment Skills Access and Bridging to Trades are excluded). The applicants must demonstrate financial need, a character reference submitted by an instructor, meet their minimum program GPA and submit an essay that describes a commitment to community involvement.

Process:

Students must complete the following application checklist:

- Complete and sign the application form.
- Fill out the budget information sheet.
- Meet the minimum GPA for their program
- In a sealed envelope, have an NVIT instructor submit a character reference letter
- Write a double-spaced essay detailing, "Community Involvement" (please include the following:
 - applicant background;
 - accomplishments;
 - goals; and
 - description of how you are involved in your community (NVIT and/or home community).

Value:

Each year, the Coldwater Indian Band will donate four (4) awards of \$550, which will be disbursed at the annual NVIT awards ceremony.

Deadline:

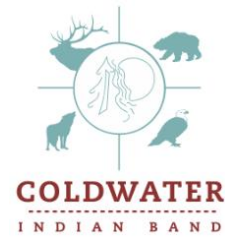
The deadline to submit the application package for the Coldwater Indian Band Community Involvement Bursary is 4:30pm, August 15th. If August 15th lands on a weekend, then the application is due the last business day **before** the deadline. Late or incomplete applications will not be accepted. Students may appeal the award decision by submitting a written letter to the award adjudication committee attention:
